V. <u>Executive Director Report</u>

A. Report

Discussion of collaboration with Marine Mills Folk School. We are fortunate to share space with them and value our ongoing relationship. We have had some difficulties with food service and bussing maintenance - thanks to Dwana these issues have been dealt with. We are exploring long-term solutions for custodial support. We are continuing to work closely with CLA. The academic embargo has been lifted and we can now begin the review process of standardized test scores. The academic committee is reviewing this and will prepare a report for October. MVS has implemented social emotional learning (SEL) curriculum which is going well, thanks in large part to Kelly Fronk and Jaime Souza. Formal reviews for teachers will happen in the coming months. We are currently at 101 for enrollment, tours are ongoing. We now have an in-house on-call sub, Lexi. This is wonderful for the students and saves us money as agency subs are much more expensive. We have the first lockdown drill this week, it has been communicated to parents that they have the ability to opt-out. Finally there have been changes in before and after school care to ensure fiscal responsibility. We are still offering this but not on a drop-in basis.
